Aloha, Commissioners,

A public hearing required for evaluation of the State Elections Officer has not been held.

A public officer's appointment and evaluation are public matters.

The personal information of the State Elections Officer is not an issue in the evaluation, raise, or reappointment.

Sunshine Law presumption is that such an evaluation will be public.

Prior year attorney advice in the Commission meeting was incorrect - that the officer has the right to an Executive Session evaluation. The contrary is true - the public officer has the right to have the evaluation in public. The public also has the right.

And as this is the presumption in Sunshine law (for non-person-information deliberations), the agenda containing executive sessions on these matters is apparently contrary to law.

It is also contrary to parliamentary procedure: to convene an executive session requires a 2/3 vote of the members present.

So if the Commission proceeds to hold an executive session without a two-thirds vote, and evaluates a public officer in executive session, it will violate both parliamentary procedure and the Sunshine Law.

This testifier urges the Commission to comply with the letter and the spirit of the law. Public matters are not for executive session, and required hearings are not satisfied by the fact of an agenda item allowing testimony. Mahalo,
