Dear Chief Election Officer Scott Nago and Members of the Hawaii Elections Commission,

I am writing to demand a full recount of all 397,135 ballots cast in the 2024 Hawaii General Election (November 5, 2024) across Hawaii County, Maui County, Kauai County, and the City & County of Honolulu, as well as clear answers regarding the chain of custody—or lack thereof—for these ballots. The Statewide Summary reports 743,135 registered voters, with 357,387 mail-in and 39,748 in-person ballots certified on November 13, 2024. However, significant discrepancies and questionable handling practices have eroded trust in the process, particularly in how ballots were shipped from counties to the state, managed at drop-off locations, and processed through the post office. Accountability and transparency are paramount, and I need specific answers to these critical issues.

Chain-of-Custody Failures and Ballot Discrepancies

Your reports claim robust security—USPS barcode tracking for 743,628 mailed ballots, tamper-evident seals on drop boxes, and dual-custody transport (January 15, 2025, summary)—but evidence suggests no consistent chain of custody was maintained. Key areas of concern include:

1. **Ballots Shipped from County to State:** The process of transferring 397,135 ballots from county facilities to state counting locations lacks documented oversight. Were these shipments tracked with unbroken custody, or were there gaps exposing ballots to discrepancies? The summary lists 67,208 ballots in Hawaii County, 63,275 in Maui, 27,049 in Kauai, and 239,603 in Honolulu—yet no logs confirm their secure transit.
2. **Drop-Off Location Distrust:** An Instagram reel by [@hawaii.republican](#) (December 9, 2024, <https://www.instagram.com/reel/DE1X28hRyQP/>) shows a “Maui County Trump Team” in tactical gear near a drop box on Election Day. This unauthorized presence—potentially within 200 feet, violating HRS §11-132—casts doubt on drop box security. Were tamper seals and daily collections truly effective, or were ballots compromised?
3. **Post Office Discrepancies:** Of 743,628 mailed ballots, 401,669 returned, but 4,534 were rejected. Were USPS delays or mishandling to blame, and how were these ballots tracked from voters to county offices? Public reports of late mail (e.g., Maui post-wildfire) amplify this concern.
4. **VSC Handling:** Late closures—Kapolei Hale past 11:00 p.m. (Honolulu), Wailuku past 9:00 p.m. (Maui), Kona at 9:40 p.m. (Hawaii)—question whether 39,748 in-person ballots were securely transported under pressure.

These gaps suggest ballots were not consistently tracked, leaving room for discrepancies that question Harris’s 240,527 votes (60.56%) and Trump’s 148,807 (37.47%).

Demand for Recount and Answers

Given this apparent absence of chain of custody, I demand a manual recount of all ballots:

- **Hawaii County:** 67,208 ballots.

Maui County: 63,275 ballots.

- **Kauai County:** 27,049 ballots.
- **Honolulu:** 239,603 ballots.

I also insist on answers to these questionable areas:

1. Detailed logs of ballot shipments from each county to the state—times, personnel, security measures.
2. Drop box collection records, especially for Maui on November 5, 2024, with seal verification.
3. Post office handling reports, explaining the 342,959 unreturned ballots and 4,534 rejections.
4. VSC transport logs for all 39,748 in-person ballots.

Action Requested

Request tomorrow recount ballots and provide the requested data from ten days of this email. , to rnaipo1966@yahoo.com or no later than March 28, 2025 . Though the November 25, 2024, deadline has passed, HRS §11-174.5 allows action with new evidence, such as the Maui incident. Confirm receipt and outline your response plan. If this requires court escalation (HRS §11-172), advise me accordingly.
