The League of Women Voters of Hawaii would like to thank the Elections Commission, the Permitted Interaction Group, Kauai County and Office of Elections for conducting this study. We appreciate the professional and constructive way the process was carried out.

The Permitted Interaction Group has made five recommendations regarding administration of elections in the future. League endorses the recommendations to have observers present for collection of ballot envelopes from ballot boxes and present at signature verification. These changes and the additional recordkeeping and daily publishing of information recommended by the Permitted Interaction Group will require a substantial increase in the demands on the staff of the counties. League believes the State should allocate appropriate funds to support these activities.

The League supports the current division of labor between Hawaii's counties and the Office of Elections. We feel the election process should be adequately funded to support the tasks assigned to all parties of the election process. The League will commit to supporting legislation that incorporates the recommended reforms and will call for an appropriation to implement these changes.

The League believes that voting is a fundamental citizen right that must be guaranteed. We support "best practices" in elections administration so that Hawaii voters can continue to vote securely, confidently and conveniently. We thank the Elections Commission, the Office of Elections, the County Clerks and staff for the work they do to support our election process.

Dear Chair Curtis and Members of the Elections Commission:

This is in response to the *Report on the Investigation into State and Kauai County Compliance with HAR 3-177 and Discrepancies in Ballot Counts and Recommendations to the State of Hawai'i Elections Commission* dated July 13, 2025, by the Commission's Permitted Interaction Group (PIG). Our office has reviewed the materials provided to the PIG and determined that the official record of voters/return envelopes, as recorded in the electronic form of the statewide voter registration system (SVRS), aligns with the collection documents created by the Kauai County Elections Division, the complete set of Business Reply Mail (BRM) receipts provided to the Kauai County Elections Division, and the transfer of return envelopes to the Kauai Counting Center. Our response also provides the list of the documents as linked attachments.

As background, the mission of the Office of Elections is to provide secure, accessible, and convenient election services to all citizens statewide. The office works cooperatively and collaboratively with the County Elections Divisions to conduct the elections. The responsibilities of each office are provided by statute with the state responsible for the printing and counting of ballots and the counties responsible for voter registration and voting, including the mailing and receipt of ballots and establishing and operating places of deposit and voter service centers.

To highlight some key points noted on the table:

- In comparison to the SVRS, there is a difference of 4 return envelopes to the collection of drop boxes by the Kauai Elections Division and the BRM receipts, noted by the gray filled boxes.
- In comparison to the SVRS, there is a difference of 21 ballots to the transfer of return envelopes to the Kauai Counting Center, noted by the green boxes.

We recognize that the differences may be attributed to human errors in the hand-count and hand-written records. Specifically, in our review of the BRM receipts provided by the Kauai Elections Division, along with the collection documents for drop boxes and receipt of electronic ballots, they reflect a total of 27,272 ballots as compared to the total recorded in the SVRS of 27,276.

Further, we have added the tracking of invalid (e.g., deficient) return envelopes that a voter may cure within 5 business days post-election, to demonstrate how the total of 219 invalid return envelopes works into the accounting records.

- [Attachment E](#) – May 12, 2025, the PIG sent a second letter to the County of Kauai contending that its review of the data reflected that 23,303 ballot envelopes were received as compared to the 27,075 ballots accepted by the

State. Additionally, it expressed that its interest was piqued by the “addition of 3,004 ballots on October 22nd.”

- [Attachment F](#) – May 30, 2025, the County of Kauai responded to the PIG in which it correctly pointed out the statewide voter registration system was the official system of record for purposes of various election metrics. Additionally, it directed the PIG to the Hawaii Supreme Court’s decision, which was informative in addressing what the court considered relevant for the reconciling of results.
- [Attachment G](#) – May 30, 2025, the County of Kauai sent the PIG an email in response to a telephone message from the PIG seeking to meet in person.
- [Attachment H](#) – June 13, 2025, the PIG decided instead to submit, in writing, questions.
- [Attachment I](#) – June 23, 2025, a response was provided by the County of Kauai in which it pointed out that the statewide voter registration was the official means by which HAR § 3-177-453(b) was met. In contrast, it pointed out that the manual hand-count taken on different forms were taken simply to track election progress and did not constitute the official count of return identification envelopes.

Based on our review of the records that had been provided to the PIG by both the Kauai Elections Division and our office, we confirmed that the number of return envelopes received – including the BRM receipts, collection of drop boxes, electronic ballots, and invalid return envelopes, are consistent with the number of ballots counted and reported by the counting center.

Deputy Clerk Lyndon Yoshioka's claim that manual hand-count discrepancies are "irrelevant" is unacceptable when ballots are entering the system unchecked. Worse, the Big Island's 19,042-ballot overcount suggests a deeper issue: electronic manipulation. If drop box ballots and mail-in counts are manually tallied, how do thousands of ballots appear without verification? Who is signing off on these electronic ballot reports? The PIG report notes that SVRS scans are the "official" start of the chain of custody, yet there's no reconciliation with manual counts, leaving room for ballots to be added or removed pre-scanning. This smells like falsification of records, potentially violating HRS §708-872, and possible misuse of business mail receipts from the post office to obscure the truth. We demand answers: 1. **Who is signing off on electronic ballot reports in the SVRS for Kauai and the Big Island?** Name the individuals responsible for verifying these counts. 2. **Where are the chain-of-custody logs for all 27,075 Kauai ballots and the Big Island's excess 19,042 ballots?** Provide detailed records, including post office mail receipts and drop box collection logs. 3. **Why are manual counts deemed "irrelevant" when they expose discrepancies?** Explain how these gaps are not evidence of electronic rigging or fraud. 4. **What safeguards prevent unauthorized ballots from entering the SVRS?** The lack of official observers during collection and signature verification is a glaring loophole.
