Dear Chair Curtis and members of the Elections Commission:





Federal DOJ Sues Hawai'i For Refusing To Provide Voter Data

The U.S. Department of Justice this week added Hawai'i to the list of 17 other states it has hauled into court as part of the Trump administration's effort to gather sensitive personal information on all registered voters across the

nation.

U.S. Attorney General Pamela Bondi wrote to Hawai'i Chief Elections Officer Scott Nago on Sept. 8 to request the voter registration information, including drivers license numbers and partial social security numbers. That request has been made to at least 40 states, according to the Brennan Center for Justice.

Nago refused, and on Thursday the DOJ filed suit in Honolulu federal court.
